Submission and Selection

- 1. Eligibility
 - Abstract submissions must be relevant to the themes and strategic objectives of VESPIIA, including support, development, advocacy, and community building for Veterans, Emergency Services, Police, and their families.
- 2. Abstract Review
 - Submissions will be reviewed by the conference committee and relevant representatives of VESPIIA. The committee's decision regarding abstract selection is final.
